

## **Privacy policy 2023 Wreckdock**

Wreckdock is committed to protecting your privacy and developing technology that gives you a powerful and safe online experience. This Statement of Privacy applies to Wreckdock family of websites and those of its affiliates and governs data collection and usage. By using Wreckdock website, you consent to the data practices described in this statement.

#### **COLLECTION OF YOUR PERSONAL INFORMATION**

Wreckdock collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Wreckdock also collects anonymous demographic information, which is not unique to you, such as your post code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Wreckdock. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by Wreckdock for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of Wreckdock website.

Wreckdock encourages you to review the privacy statements of websites you choose to link to from Wreckdock so that you can understand how those websites collect, use and share your information. Wreckdock is not responsible for the privacy statements or other content on websites outside of Wreckdock and Wreckdock family of websites.

#### **GENERAL USE OF YOUR PERSONAL INFORMATION**

Wreckdock collects and uses your personal information to operate Wreckdock website and deliver the services you have requested. Wreckdock also uses your personally identifiable information to inform you of other products or services available from Wreckdock and its affiliates. By completing and sending an enquiry form through this website or other Wreckdock websites, you are providing explicit permission to be contacted by email, SMS or telephone about Wreckdock property investment offerings and promotions and agreeing to our having possession of and retaining any information that you provide to us. Upon initial contact, you will always be given an opportunity to opt-out of future communications. You may

also opt-out using the unsubscribe function in the email you receive from us. Wreckdock may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered. Wreckdock does not sell, rent or lease its customer lists to third parties. Wreckdock may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party.



In addition, Wreckdock may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Wreckdock, and they are required to maintain the confidentiality of your information. Wreckdock does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Wreckdock keeps track of the websites and pages our customers visit within Wreckdock family's websites, in order to determine which products and services are the most popular. This data is used to deliver customized content and advertising to customers and potential customers of Wreckdock whose behavior indicates that they are interested in a particular subject area. Wreckdock websites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Wreckdock or the site; (b) protect and defend the rights or property of Wreckdock; and, (c) act under exigent circumstances to protect the personal safety of users of Wreckdock website, or the public European Union Users

# Legal basis under EU General Data Protection Regulation for processing personal information of EU residents ("Personal Information").

Where you have consented to data processing, your consent provides the legal basis to process your Personal Information. You have the right to withdraw consent at any time. We may also process your Personal Information on the basis of contractual necessity to perform a contract we have with you. For example, when we process your credit card details when you provide them to make a payment. We may also process your Personal Information on the basis of our legitimate interests, including in providing and improving our services.

For example, Wreckdock has a legitimate interest in understanding your website visit history so we can assess your interests and provide a better experience. We also have a legitimate interest in providing and developing interesting features to provide to our users. Where we rely on legitimate interests to process your Personal Information, you have the right to object to such processing (meaning that you can ask us to stop). #### **USE OF COOKIES**

Wreckdock websites use cookies (small files stored on your browser), web beacons, pixels and device identifiers (collectively also known as "cookies") to help us personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the web server that you have returned to a specific page. For example, if you personalize Wreckdock pages, or register with Wreckdock or its family of websites or services, a cookie helps Wreckdock to recall your specific information on subsequent visits.



This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.

When you return to the same Wreckdock website, the information you previously provided can be retrieved, so you can easily use Wreckdock features that you customized. You have the ability to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. #### **Security of your Personal Information**

Wreckdock secures your personal information from unauthorized access, use or disclosure. Wreckdock secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure.

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.

#### **RETENTION**

We will retain your personal information for the period necessary to fulfill the purposes outlined in this Privacy Notice unless a longer retention period is required or permitted by law.

#### **REFERRAL PROGRAMS**

Should you engage in our referral program to tell an individual about Wreckdock, we will ask you for their name, email address and phone number. You must ensure you have the person's permission to do so for the purposes detailed in this Privacy Notice. We will contact them by email and/or phone number to discuss Wreckdock product offering. Wreckdock stores this information for the sole purpose of following up on the contact request and tracking the success of our referral program.
